Send \$150 FEE for our service to complete all Texas DMV paperwork.

### PURCHASE A SURETY BOND

- **WAIT** for the bond company to send you an application.
- A **SEPARATE FEE** will be required by the bond company.
- Pricing is based on the value of the vehicle, camper, motorcycle, trailer.

### FIND YOUR LOCAL TAX OFFICE

- After bond is processed, a final packet will be mailed to you.
- **TAKE PACKET** to your DMV local tax office **WITHIN 30 DAYS**.
- Tax, Title and Registration fees will be required by the DMV Tax Office.
